



Allworx[®] Software Products End User License Agreement

PLEASE READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT CAREFULLY BEFORE INSTALLING THIS SOFTWARE OR UTILIZING ANY PRODUCTS OR SERVICES CONTAINING THIS SOFTWARE.

For purposes of this End User License Agreement ("Agreement"), "Software" is defined as any Allworx Corp. ("Allworx") computer program or application with which this Agreement is included and any updates or maintenance releases thereto.

The use by you of any services or content accessible through the Software may be subject to acceptance of separate agreements with Allworx or third parties. This Agreement applies to all versions of the Software and other branded or customized versions unless otherwise agreed. Do not use the Software until you have carefully read the following Agreement. This Agreement sets forth the terms and conditions for licensing of the Software from Allworx to you, and installing and using the Software indicates that you have read and understand this Agreement and accept its terms and conditions. If you purchased a license for the Software from a retail store or directly from Allworx or other Allworx - authorized distribution channel, and do not agree with this Agreement, promptly return the Software and accompanying items to the place of purchase. If the Software was pre-installed on your computer or device or came packaged with your computer or device at no extra charge, and if you do not agree with this Agreement, do not use the Software.

License and Certain Restrictions. You are granted a limited non-exclusive, non transferable, and non sub licensable, license to use a copy of the enclosed Software on the device computer(s) connected by any supported network connection to your purchased Allworx server. You may make one (1) copy of the Software for your own backup or archival use only.

General. It is prohibited to give copies to a person who has not purchased the appropriate license for the Software from Allworx; to disclose interfaces to the Software, to install the Software on computers or devices used by individuals who have not purchased the appropriate licenses for the Software from Allworx; or to duplicate the Software by any other means including electronic transmission. The Software in its entirety is protected by U.S. and International intellectual property laws. The Software also contains Allworx trade secrets, and you may not decompile, reverse engineer, disassemble, or otherwise reduce the Software to human-perceivable form or disable any functionality which limits the use of the Software. You may not modify, adapt, translate, rent or sub license (including offering the Software to third parties on an applications service provider or time-sharing basis), assign, loan, resell for profit, or distribute the Software, disk(s), or related materials or create derivative works based upon the Software or any part thereof. You may not copy or modify the Software in whole or part, or use trade secret information contained in the Software, to develop software to interface with any Allworx Software.

Termination. This Agreement may be terminated by Allworx immediately and without notice if you fail to comply with any term or condition of this Agreement. Upon such termination, you must immediately destroy all complete and partial copies of the Software, including all backup copies. From time to time, without notice, Allworx may change the terms and conditions of this Agreement. For the latest version of this Agreement, contact Allworx dealer. Your continued use of this Software will indicate your agreement to the change.

Limited Warranty. Allworx warrants that the software owned by Allworx ("Allworx Software") will perform substantially in accordance with the Allworx manuals, guides or any other printed material that Allworx provides ("Documentation") under normal use for a period of ninety (90) days from the date of installation. Allworx does not warrant that the Software will meet your requirements or that the operation of the Software will be uninterrupted or error-free. As Allworx' sole obligation and end-user customer's sole remedy, Allworx shall, at its option and expense, either repair or replace the Allworx Software or refund the fees paid for the nonconforming Product. This limited warranty does not extend to any Allworx Software which in the sole judgment of Allworx, has been subject to neglect, improper installation or accident, nor does it extend to any Allworx Software which has been repaired or altered by other than Allworx. EXCEPT AS STATED ABOVE, THE SOFTWARE IS PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED OR STATUTORY, INCLUDING, WITHOUT LIMITATION, WARRANTIES OF MERCHANTABILITY, NONINFRINGEMENT AND FITNESS FOR A PARTICULAR PURPOSE. IN NO EVENT WILL ALLWORX BE LIABLE FOR ANY DAMAGES, INCLUDING, WITHOUT LIMITATION, INCIDENTAL AND CONSEQUENTIAL DAMAGES AND DAMAGES FOR LOST DATA OR PROFITS ARISING OUT OF THE USE OR INABILITY TO USE THE SOFTWARE, EVEN IF ALLWORX HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. IN NO EVENT SHALL ALLWORX'S LIABILITY FOR ANY REASON WHATSOEVER EXCEED THE AMOUNTS PAID BY PURCHASER FOR THE SOFTWARE. ALL CLAIMS OF ANY TYPE BY PURCHASER AGAINST ALLWORX MUST BE BROUGHT WITHIN ONE YEAR OF ACCEPTANCE OR BE FOREVER BARRED. The Software is a "commercial item," as that term is defined at 48 C.F.R. 2.101 (OCT 1995), consisting of "commercial computer software" and "commercial computer software documentation," as such terms are used in 48 C.F.R. 12.212 (SEPT 1995) and the Department of Defense Federal Acquisition Regulations Sections 252.227-7014 (a) (1), (5). Consistent with 48 C.F.R. 12.212 and 48 C.F.R. 227-7202-1 through 227-7202-4 (JUNE 1995), all U.S. Government End Users acquire the Software (or Licensed Product) with only those rights set forth herein.

Such provisions are made expressly for the benefit of and are enforceable by such third-party suppliers and vendors in addition to Allworx.

General Provisions. This Agreement sets forth Allworx and its employees, officers, directors, affiliates, agents, and representatives ("Representatives") entire liability and your exclusive remedy with respect to the Software. You acknowledge that this Agreement is a complete statement of the agreement between you and Allworx with respect to the Software, and that there are no other prior or contemporaneous understandings, promises, representations, or descriptions with respect to the Software.

This Agreement does not limit any rights that Allworx may have under trade secret, copyright, patent, or other laws. Representatives of Allworx are not authorized to make modifications to this Agreement, or to make any additional representations, commitments, or warranties binding on Allworx, other than in writing signed by an officer of Allworx. Accordingly, such additional statements are not binding on Allworx and you should not rely upon such statements. If any provision of this Agreement is invalid or unenforceable under applicable law, then it is, to that extent, deemed omitted and the remaining provisions will continue in full force and effect. The validity and performance of this Agreement shall be governed by New York law (without reference to choice of law principles), except as to copyright and trademark matters, which are covered by federal laws. This Agreement is deemed entered into at Rochester, New York, and shall be construed as to its fair meaning and not strictly for or against either party.
